# How can you grow your business with podcasting?

If 2018 was the year where podcasts began exploding in popularity, 2019 has shown no signs of that growth slowing down. Several Lincolnshire businesses have launched their own broadcasts this year, could you be set to join them?

Some podcasts talk about music, theatre, and news, however, there has been a surge of business-based podcasts launching this year. Businesses in our region are starting to see the value in podcasting, and for good reason.

A podcast is a perfect medium to position yourself as the go-to expert in your industry. It underlines personal branding efforts and goes a long way to spread your influence, especially if you have the knowledge to share. The authority that you are sure to gain from podcasting has a wide reach and there is no reason not to get started as soon as you

#### So how to begin?

A good quality business podcast is relatively cheap and very easy to set up. You'll need some good quality microphones, an audio mixer and some recording and editing software. All this can be bought for less than £200, meaning the price of entry to making your own podcast is relatively low. If you'd like to up the calibre of your equipment, add some pop filters to your microphones and upgrade to some condenser microphones. The difference in audio quality is noticeable, but not necessary to get started.

Once you've nailed down what you'd like your podcast to focus on, whether it's your industry niche or you giving your opinion on the latest industry trends, it's easy to get talking. Plan out a few topics you'd like to discuss and let the conversation flow freely between yourself and any other guests. Don't dwell on a single point for too long, but be sure to talk around the whole subject, covering every angle. This makes for an entertaining and engaging episode.



#### How do you get yourself heard?

As soon as you've recorded the first episode, you'll want to get your podcast heard. Distributing a podcast is easy with the right tools.

Anchor.fm is a free online platform which aims to take the hassle out of creating a podcast without sacrificing the quality. Simply upload your podcast audio to the service and Anchor will distribute it to all the major podcast listening platforms.

You'll be heard on Spotify, Apple Podcasts, Google Podcasts, Pocket Casts and many others, including Anchor itself. The certification process can take up to two days for some platforms, but subsequent episodes will be available to listen to much quicker.

Anchor allows you to see detailed analytics of your podcast's performance. You can see at a glance how many listeners each episode attracted, what device they were using, what listening service they found you on and where in the world they tuned in from.

This data should allow you to better present your podcast to the audience that is most interested in your opinions.

If you're looking for a quick and easy way to get started, Anchor.fm is a great

#### Make your podcast go further

Your audio podcast will attract a lot of attention when it's out in the wild, but you need to be shouting about it. Show your followers and stakeholders that you've taken a step in a new direction by recording your podcast with a camera.

A video version of your podcast opens up a range of new possibilities. Firstly, you can now upload your podcast with video and audio to other streaming services, such as YouTube, where you can garner a whole new audience.

is to use it as organic social media. Post interesting snippets of your podcast on your Facebook, Twitter, Instagram and LinkedIn. Let everyone see what you're doing and provide a link to the full podcast where they can follow and be notified of new episodes.

#### **Maintaining momentum**

It's easy to think that once your podcast has been created and you've uploaded a handful of episodes that's the end of it, but maintaining the initial momentum takes a lot of effort. To make a great podcast, instead of a good one, there need to be weekly uploads of new episodes across multiple seasons.

# The Power of Networking

Networking – it's everything and everywhere! It's virtual connections, it's face-to-face relationships, it's people you don't even know, it's virtually anyone you communicate with, from a LinkedIn interaction to an ingoing or outgoing call, which all bring the potential of joining your 'network'

If networking isn't a part of your marketing and communications strategy, it should be, it has long been a core business skill and should not be neglected as communications become more digital because the principles still remain the same, whether it be digital or face-to-face networking, the common goal is to build relationships to further your business and career.

Making the most of the content you create is one of the biggest challenges that businesses face, and yet it is also the most important. Podcasting provides so many options and opportunities to use your content for more than what it was meant for. Using video to create organic social media micro-content and clips advertising your new episodes will bring in new listeners who may not have previously been engaged with your business.

The authority of the podcast isn't looking to go away anytime soon. In fact, there has never been a better time to get started. Isn't it time that you sat down, hit record, and began your podcast journey?



# Is your business missing out on a grant or 12 hours of FREE support?

Nick Peel, Managing Director of Stokes Tea and Coffee said: "For any business looking to apply for this pot of funding, we would definitely recommend it. It's allowed us to really explore possibilities that we wouldn't have been able to without it."

# Chamber survey shows increase in confidence for businesses

New figures show that after a significant drop in confidence levels recorded in Q1, we can now report this confidence has bounced back for Lincolnshire businesses.

Sales have fallen but orders increase though both remaining positive, overseas sales fall but keep strong, however Lincolnshire Chamber of Commerce have seen record numbers of exporting numbers through April and May.

Recruitment activity has dropped, compared to Q1 where recruitment activity held strong, we could be seeing record levels of employment and with investment plans for both, capital and training, we could be seeing employers looking at upskilling current workforce.

The balance of Lincolnshire businesses reports improved cashflow – a key

indicator of business health – and which took a turn for the worse in Q1.

Dr David Gray, Economics Programme Development Planner & Principal Lecturer at Lincoln International Business School, said: "It appears that the Lincolnshire economy is quite resilient in the face of the Brexit uncertainties. Pay is likely to remain a key pressure as with other costs linked to a weaker exchange rate"

Simon Beardsley, Chief Executive of Lincolnshire Chamber of Commerce, said: "Although, the results from Q2 suggest that Lincolnshire businesses have moved past any issues leading up to the (now missed) March Brexit deadline and are starting to adapt accordingly, it still remains ever more important to avoid a messy and disorderly Brexit."

### Lincoln Drill Hall campaign reaches half-way point with grant funding

The charity-run arts centre, Lincoln Drill Hall has been awarded a £160,000 grant to help it secure a sustainable future over the next four years.

The Lincoln venue will receive the first £60,000 of the funding this year, with the rest spread over the following years.

The generous grant funding has been awarded from Esmée Fairbairn Foundation, one of the largest independent grant-markers in the UK.

Each year, Lincoln Drill Hall needs to raise £130,000 to continue its work in the community after a series of reductions of public funding.

In February, the not-for-profit venue launched its 'Be a Brick' campaign, asking members of the public and businesses to donate to Lincoln Drill Hall £10 or £50 each year. In return, donors get to choose a colourful, smiling brick with their name and a message of their choice on a virtual wall which represents the half a million bricks that make up the historic building.

The money from Esmée Fairbairn Foundation brings the total amount raised so far this year to £80,930 - bringing it past the halfway point in its fundraising

The £160,000 is being given to support the Drill Hall in exploring, developing and implementing new partnerships that aim to deliver new income streams; helping the charity to be more resilient and more



sustainable in the long term.

Chief Executive of Lincoln Drill Hall, Chris Kirkwood said:

'This is an absolute game-changer for us. It's a testament to the value that we offer the City of Lincoln as a professional arts centre and as a charity that's here for the whole community. That one of the country's biggest arts funders wants to help is absolutely fantastic and it will go a long way to ensuring we'll be here for years to come. This money buys us the time to explore new partnerships with stakeholders and new opportunities which would mean we'd no longer be facing the constant threat of closure.

"We still need to raise another £49,070 pounds this year, but getting to the halfway point within five months of campaigning is an incredible achievement. I'm extremely grateful to everyone who has given us their support. You're a brick."

NWCH's Acting Director, Charlie Blackwell said: "NWCH has worked




