CHAMBER OUARTERLY ECONOMIC SURVEY 04

THE Lincolnshire Chamber of Commerce's Quarterly Economic Survey, part of the UK's largest independent business survey and a leading indicator of UK GDP growth, has found that businesses have high confidence going into 2022, but tempered with significant price pressures constraining activity.

Running from November 1-21, the survey was conducted prior to the Omicron variant impacting on the nation.

UK market figures have seen a small dip but remain relatively strong, with both sales and orders moving further into positive territory and returning to 2018 levels, with sales shifting from +38 to +29 and orders increasing from +27 to +11.

Overseas sales and orders have returned to negative territory following a positive Q3, with sales moving from +15 to -13 and orders slightly decreasing from 0 to -7.

Future recruitment intentions have held strong this quarter rising slightly from +16 to +18, while future recruitment plans remain high at +32 indicating that we should see strong levels of recruitment in Q1 2022.

The balance of responses of businesses expecting to increase prices in

the next three months smashed previous records, increasing from +59 to +68.

Raw material prices and other overheads remain the key drivers of these price pressures, with inflation remaining the biggest concern for 66 per cent of respondents.

Despite the mixed set of results, there is high confidence that 2022 will see improvements in terms of profitability and turnover, with the latter moving from +41 to +50.

Simon Beardsley, chief executive at Lincolnshire Chamber of Commerce, said: "Our latest survey shows a positive outlook for the economy going in to 2022, however with companies now having to tackle the impact of Omicron

and further changes to rules on imports and exports of goods to the EU, as well as ongoing supply chain disruption and recruitment challenges and rising energy costs, means there are significant hurdles for businesses in the months ahead.

"As a Chamber network we have lobbied for support and if the current restrictions persist or are tightened further then a much more comprehensive support package that matches the scale of any new measures, will need to be put in place.

"The focus is to create an environment for Lincolnshire businesses to grow, thrive and succeed."

Cllr Colin Davie, executive councillor for economy at the county council, said: "There's some renewed confidence that 2022 will see continued recovery for our county businesses, with many looking to recruit now and in the future, and a more positive outlook.

Globally though conditions remain tough with new variants of Covid, price increases and supply chain difficulties all playing a part in continued pressures.

"Before Christmas, the government announced further financial support for specific sectors most affected by the spread of Covid 19.

"We're expecting more information on this soon and along with local support, I hope Lincolnshire businesses will continue to have confidence in an improving outlook."

Chamber Network finds rising cyber-attack fears

MORE than half of firms believe their exposure to cyber attacks has increased due to working from home arrangements. One in ten firms have been the victim of a

cyber-attack in the last year. This rises to more than one in seven for

larger firms with more than 50 employees. Only one in five firms have cyber-security

accreditations in place. A new survey of almost 1,000 UK firms, of all

sectors and sizes, has revealed that more than half believe their IT systems have been left more exposed to attack following the huge increase in people working from home during the pandemic.

The research by the British Chambers of

Commerce and IT company, Cisco, also found that one in 10 firms said they had been the victim of a cyber-attack in the last year, rising to more than one in seven for larger firms.

Yet despite this, four out of five firms said they did not currently have accredited cyber-security measures in place to protect against attacks.

Ongo's big 2021 roundup

IT WAS A SUCCESSFUL YEAR

ONGO is thanking their customers and colleagues after a successful year of new homes, community projects, supporting each other and more involvement than ever with tenants.

Some of their key highlights include over 180 new homes over the last 12 months. Building 78 homes for affordable rent, shared ownership, rent to buy and outright sale, along with acquiring 111 properties in Lincoln.

Myos House, Ongo's outstanding dementia care scheme, was just one of the developments completing this year. It's made up of 25. modern two-bedroom apartments and specially designed, spacious communal spaces for residents to socialise and relax.

Over 670 people have been given employment support, with 400 now in work or training. Their mental health services have supported more than 300 individuals since

March, making it their busiest year vet.

Huge new projects have been launched. These include Kickstart, a government funded scheme, to get young people into placements. To date Ongo has supported 70 young people into jobs within 31 companies, with many being taken on full time after their placement is up.

Endeavour which supports disadvantaged people from communities across North Lincolnshire. focusing on mental health issues and barriers to work also begun. And My Move, an online platform allowing users to browse homes and apply direct, along with Reconnect, a post- pandemic programme to re-engage members of the community.

Over 600 people have been given support to improve their financial situation, with £692,732 of extra income gained. More than 280 tenants have been helped to sustain their tenancy, and overall there has been a decrease in rent arrears.

Partnership working has continued with the Police on a number of operations, with Ongo's cuckooing work winning 'Project of the year' at the National Resolve ASB awards, and their Safer Streets project in Westcliff being hailed a huge success.

One further exciting achievement was appointing a Sustainability and Carbon Reduction Manager to coordinate and deliver their aim of being a net zero organisation by 2050.

Financially they have remained at a V1 rating, with their governance being upgraded to G2.

Steve Hepworth, Chief Exec at Ongo said: "Looking ahead we're going to have a real focus on delivering great services to our tenants as well as building new homes and developing our environmental work to reduce our carbon footprint."

Emergency service LIVES shortlisted for **NHS** Award

LINCOLNSHIRE'S emergency service charity LIVES is delighted to announce that its Community Emergency Medicine Service (CEMS) and Falls Response Unit have been shortlisted for Best Not for Profit Working in Partnership with the NHS at the HSJ Partnership Awards 2022.

The development of the charity's CEMS and Falls Response services have helped improve patient care, save resources across the healthcare system, and deliver an excellent patient experience. Both services use LIVES emergency responding skills to bring care to those unwe patients who might otherwise be admitted to hospital.

Working with East Midlands Ambulance Service (EMAS) and NHS Lincolnshire, LIVES deploy their doctors, paramedics and nurses to emergencies that have originated via a 999 or 111 call. The main aim is to provide treatment and care for unwell patients within their own homes or communities, helping to avoid visits to A&E and hospital admissions

During 2020-21, the CEMS team were called to 2,437 unwell patients; 56% of those were able to stay at home with no further treatment, 28% of patients attended A&E, while 11% were referred to another healthcare professional. From August 2020 to year end, the Falls Response Unit has attended 1,538 patients. Of these, 54% have remained at home following their 999 call.

The HSJ Partnership Awards recognise the outstanding contributions made to healthcare in what has been an exceptional and challenging period in the sector. Chris Cole, head of operations at LIVES, said: "We are delighted to have been shortlisted for this award, recognising the collaborative efforts and dedication of our staff members to successfully implement our CEMS and Falls Response services

'We are committed to delivering improved outcomes for our patients, and to be chosen among the other incredible nominees is a wonderful achievement. This nomination has been a tremendous boost to our staff and volunteers at LIVES and I am sure it will bolster our continued efforts to improve our services."

The official HSJ Partnership Awards ceremony will be held on Thursday, March 24, at Westminster Park Plaza in London.

highlighted the need for more support in hospitals in identifying palliative care needs.

This research informed a business case for the role of Community Care Nurse Specialists. These nurses,

employed by St Barnabas Hospice,

were placed in Lincoln County and Boston Pilgrim hospitals to educate clinicians on how to identify patients in their last year of life and develop person-centred planning. Without support from United Receiving the award Photo: CityX

The two nurses – Ashleigh Robinson (Lincoln) and Holly Musgrave (Boston) began their roles as Community Care Nurse Specialists in 2019. In the past years, they have been pivotal in having important conversations with patients and families around future care needs.

In their first year in the role, they supported an incredible 552 patients to access end-of-life care sooner. 36.1% compared to before their roles existed.

The Community Care Nurse Specialist roles are now a highly valued part of the local healthcare system, and it is anticipated that this work will be able to expand across other hospital settings that care for the residents of Lincolnshire.

New generation of exporters are needed to power economic growth

RESEARCH CONTINUES TO SHOW OOR OVERSEAS TRADE

THE Chamber Network, headed by British Chambers of Commerce (BCC), is setting out 60% of companies which are its manifesto to recruit legions of new UK exporters as its research continues to show poor overseas trade growth:

■ In Q4 of 2021, just over a quarter of exporting firms (29%) saw their overseas sales increase

Almost half (47%) saw no change, and a quarter (24%) reported a decrease.

This is despite substantially more firms reporting improved domestic conditions, with 45% confirming increased UK sales in Q4.

BCC research also shows that exporters are uniquely facing a wide range of issues, from inflationary unprecedented pressures and global supply chain crises to a raft of new requirements flowing from the EU trade deal.

The Manifesto sets out a comprehensive list of steps to get more UK businesses, currently just 10%, involved in

international trade. This compares to more than members of an Accredited

Chamber of Commerce. To do this the BCC is working with the whole of its Global Business Network, both within the UK and in 76 markets across the world, to help encourage the shift.

It is making the move after 23% of firms surveyed said finding a business partner or distributor overseas would encourage them to either start exporting or export more.

The manifesto sets out a number of steps that the UK government could take to help firms trade with the EU and to make sure that any new trade agreements put the interests of business at their heart.

Now that the UK has left the EU Common Market, any goods coming from abroad will most likely attract duty and VAT. This fact concerns traders, businesses and private individuals buying goods from other countries. When comparing prices, you will now need to factor in import taxes.

The Alsim ALX worth £35,000, is a standout feature of the newly developed workshop at Newark College's interim IASTI site, where students get hands-on with the tools and technologies used within the aviation industry.

The institute's aspiring pilots are

"The simulator allows experience within different aircraft types that will prove both enjoyable and important whilst allowing progress from light aircraft to small multi engine aircraft within the simulator environment."

The IASTI enables students to learn from aviation professionals as they develop the skills needed to Towns Fund Board and is funded become pilots, engineers or flight dispatchers, leading to Level 3 Diplomas in Aviation Operations or Aircraft Maintenance.

Bespoke study programmes are co-designed by industry experts to provide a sustainable talent pipeline within the sector.

The IASTI is one of nine priority projects developed by Newark

through the Government's Towns Fund initiative.

A planning application, which will see a multi-million-pound premises for IASTI built in the Centre of Newark by 2023, is awaiting approval.

Until then students are based at the specialised interim IASTI facility at the Newark College campus.





Lincs & Notts Air Ambulance sign off 2021 as busiest year

A LOT has happened at LNAA in 2021, from moving to a new headquarters to upgrading the helicopter, the charity hasn't stood still through what has been a monumental year of change.

And the numbers reflect the pace of transformation with the crew having responded to more than 1,400 missions in 2021. Compared to 1.095 in 2020 and 877 in 2019, it's a significant leap.

The addition of a second helicopter in the summer came in response to an anticipated surge in visitors to the Lincolnshire coast as lock-down measures eased.

This contributed to the rise in callouts as it became the busiest summer the charity had ever had.

Throughout the year additional, highly skilled doctors and paramedics have joined LNAA with some travelling from Aberdeen, Kent and even Lisbon to be part of a team that

is leading the way in this specialist sector. This meant that by September, crews were able to respond day and night using a mix of the helicopter and critical care cars.

The charity teams and crew moved into a new, purpose-built headquarters in Lincoln and celebrated the official opening in September when HRH The Earl of

Wessex, officially opened the building. Another stride in clinical care came

with the introduction of blood plasma. Blood was already carried on board

but plasma was added because it is the component of blood that helps it to clot - integral to the care given at the scene of a traumatic incident. anywhere within the 3,500sq miles LNAA covers.

'Our crews continue to be out there and, just like their NHS colleagues,

they are dealing with the added pressure and complexity the spread of Covid brings, said CEO Karen Jobling. The only difference is that we are there purely because of the generous donations we receive from our communities.

She added: "We are so pleased that we have been able to be there for more patients in 2021.

Of course, with each mission costing on average £3,500, it comes at a cost.

It is only because of the generosity of our supporters that more patients have been helped by a crew with the highest skills and standards in pre-hospital care.

The essential criteria for this fund are as follows: proposals should be capital focused but can include a revenue element which should not exceed 10% of the project cost schemes must be more than minimum grant requested of £500,000

projects that are related to clean growth and driven by R&D and innovation will be considered, but they must relate to one of the following LEP game changers or sectors:

- UK Food Valley
- Humber Freeport
- Clean energy
- Defence

- Visitor economy - Health and care

"The funds must be spent by July 2024, and outcomes must be delivered by 2026/27, so any proposals submitted need to be already well progressed in terms of design, planning and match funding," said Pat Doody.

Match funding identified must be a minimum of 50% (further grant funding level restrictions may apply to SMEs according to government subsidy regulations).

Schemes must demonstrate direct public/private investment leverage and job creation and/or research and development outputs with clear clean growth-related outcomes.

Examples could include: an innovation, research and development project focused on

clean growth / net zero reducing carbon emissions by 2027 reducing nitrogen oxide and particulate emissions contributing to Green Masterplan Net Zero targets decarbonisation of the National Grid or heat production creating EV charging points demonstrating the use of Modern Methods of Construction (MMC)

introduction of new clean growth-related products to the market
