Give the gift of better mental health

LINCOLN-BASED counsellors, who successfully supported hundreds of clients throughout the Coronavirus pandemic - have launched a fundraising drive to help scores more people in urgent need of their "life-saving" services.

Professionals working at The Naomi Watkins Counselling Hub CIC, which has seen a huge surge in demand from its help over the past 18 months, is taking the crowdfunding route to raise £10,000, so that it can help those on its fast-growing waiting list, many of whom cannot

At the height of the pandemic, NWCH - which is based on the city's Allenby Business Park was determined clients would not miss their sessions, despite being forced into lockdown. having to work from home and care for school children.

Although Chief Executive Naomi Watkins-Ligudzinska's team was supporting 800 individuals a month, counsellors managed to continue their valuable work by transitioning from face-to-face sessions to providing telephone and online counselling.

"So many people's mental health was suffering because they couldn't socialise with

workplace camaraderie and had to help children with their schoolwork," said Naomi.

"We have received some fantastic feedback from our former and current clients and now we want to help people on our waiting list - who can include individuals from children aged four to young people and adults.

"This work is urgent because we know everyone's mental and physical health has been strained by all sorts of issues, including the often-hidden trauma of sexual, child and domestic abuse, as well as selfharm, suicide ideation and, of course, bereavement.

"We know they urgently need our help, but the pandemic has really stretched our resources, so we hope our crowdfunding campaign will give us the necessary financial support we need to reduce, or even clear our waiting list," said Naomi.

Naomi's Crowdfunder campaign has not only



received the full support of her colleagues at the Hub, but many sponsors have stepped forward with a range of offers to encourage people to donate in the hope the campaign reaches its target.

How the East Midlands could benefit from an Australia trade deal

shoemaking industry, the region's manufacturers and high-quality food exporters could all be big winners from an Australia free trade deal.

Manufacturing and chemicals: machinery and chemicals exports from the East Midlands to Australia were worth £130m last year. Cutting tariffs of up to 5%, removing red tape and aligning regulations would make exporting easier and open up opportunities for growth.

Shoemaking: cutting the 5% footwear tariff could open up new opportunities for Northampton's renowned shoemakers, such as Tricker's, to export more high-end shoes and boots to Australia.

Food: cutting tariffs on food and drink could boost exports for the East Midlands's food producers. Buxton's Bradburys Cheese sells nearly \$3m of British cheese in Australia every year but wants to boost that by up to 60% with the removal of tariffs on their goods.

Second highest Audit award for Council's grant support of businesses

AUDITORS have awarded West Lindsey District Council the second highest award for its awarding of Covid-19 Business Grants.

Between June and October, Auditors monitored the programme and found that the scheme was to be awarded with a "substantial assurance" rating.

The Council was noted as being focused on getting payments to support businesses out quickly during the early parts of the pandemic, while it was recommended that

additional assurance checks could have taken place earlier in the application process rather than in post payment.

Chair of the Governance & Audit Committee, Cllr John McNeill, said: "We take the recommendation made by auditors on board, and I can confirm that additional assurance checks now do take place prior to payment for all subsequent and current grant schemes set up to support businesses in the pandemic.

Auditors have confirmed that in all cases all the checks and assurance checks were followed in every case - as mentioned we have now changed our strategy and thank the auditors for their recommendation.

Senior Growth Strategy & Projects Officer, Wendy Osgodby, said: "Looking after eligible businesses at the start of the pandemic was our main focus. I am immensely proud of the work that we have done as a Council to support all those local shops that make up

our streets, towns and villages in West Lindsey. Although we are in a different stage of the pandemic, we still have a part to play to help where we can, and I want to thank everybody in the team for their efforts over the past 18 months."

The Audit was awarded as part of a series of independent Audit Inspections on different Council areas over the past few months.

Charitable Group to deliver on its commitment to keep making a difference IT IS THE DRIVING FORCE BEHIN THE £460,000 OF GRANTS AWARDED

THE Alan Boswell Group Charitable Trust continues to deliver on its commitment to make a difference to charitable causes in the areas that we operate in.

They wanted to share what these donations mean to some of the charities who have been given

The current Charitable Trust sub-committee have assessed 111 applications made to the Trust, sent feedback to dozens of charities and have been the driving force behind the £460,000 of grants awarded in the last 12 months.

Here are some of the amazing impacts the grants have made:

EAST NORFOLK RIDING FOR THE DISABLED

The Trust donated £4,000 to the charity and they have put the money to excellent use.

Some of the items have been able to purchase include a specialised saddle and handles to support riders, First Aid and Safeguarding training for instructors, training sessions for volunteers and Covid-19 safety products.

NORTH NORFOLK MACMILLAN CENTRE

Macmillan Cancer Support invested £2.2m in the North Norfolk Macmillan Centre to help thousands of

people access cancer treatment and support closer to their homes.

They relied on grants such as the £10,000 donated by Alan Boswell Group to cover the costs of the build and despite an unprecedented drop in income of up to 50 per cent during the pandemic, the building is now complete and the first patient has received treatment.

EATING MATTERS

Eating Matters are a Norfolk based charity which offers counselling for people age 11-plus with mild to moderate eating disorders in the community.

They applied for a grant of £2,500

back in March 2020 to support their during the last two weeks of services throughout the pandemic, life. meaning delivery via online/telephone counselling.

At the time of writing, they supported 264 clients, 134 of which donated £6,608.00. were under the age of 25.

ARTHUR RANK HOSPICE

The hospice ran the 'Help Us Be There' appeal back in 2020 where they aimed to raise £100,000 to fund the recruitment of two full time healthcare assistants.

The new colleagues were needed to meet the demands of people wishing to receive end of life care in their own home, overnight,

The appeal was a great success and raised a total of £140,000 in the end, of which the Charitable Trust

NANCY OLDFIELD TRUST

The Trust offers accessible accommodation, canoeing, sailing and motor cruising on the Norfolk Broads and put together an 'Enhanced Accessibility' project to improve the accessibility of their premises.

They were given a grant of £3,746.48 to purchase an automatic door system.

Work starts on Roman Gate Court in Lincoln

NEW ONE-BEDROOM APARTMENTS UNDERWAY FOR PEOPLE AGED OVER-55

WORK has started in Lincoln in preparation for construction of 24 new apartments for people aged

Lindum Group is currently on site at Roman Gate Court, off Nettleham Road, just north of the city centre.

Work to set up the site compound is underway with construction of the new homes scheduled to begin in January.

LACE Housing, which is a nonprofit making association specialising in the provision of housing and support services for older and vulnerable people, appointed Lindum Group to build the new homes following a competitive tender process.

The finished scheme will provide affordable, safe and secure homes and will consist of 24 one bedroom apartments, as well as a communal lounge facility, mobility scooter store and landscaped gardens.

The scheme is located within easy reach of convenience stores, supermarkets, takeaways, doctor's surgery and public transport with excellent access to the A46 Lincoln

Site manager Andy Foster said works, Lindum is constructing a bridge to allow access to the site without vehicles having to pass through the neighbouring housing



"We are getting all the preliminary work completed so we can start on site fully in January," he said.

"We are building access over the stream, which is known locally as The Meg, and this will reduce construction traffic through the housing estate by about 90 per

"The build will be managed by that, as part of the preliminary Lindum with the support of our subcontract team, which is made up of some reliable local businesses.

We expect to be onsite for around 60 weeks so the homes should be ready for occupants by spring 2023."

The scheme is one of two new housing projects by LACE.

As well as Roman Gate Court, Collinson Court will provide 16 one-bedroom and two-bedroom affordable apartments with communal facilities on land off Willoughby Road in Scunthorpe.

LACE Housing's CEO Nick Chambers said: "Despite the many challenges experienced over the past year, we are delighted that works have now begun on a further development of 40 much needed homes for older people in Greater Lincolnshire.

E TO covid-19. These include the Self Employment Income Support Scheme, the Coronavirus Job Retention Scheme and any other payments such as Self-Isolation Payments, Local Authority Grants and the Eat Out to Help Out Scheme.

HELP TO PAY

Whilst the economy is still trying to recover from the impacts of covid-19 and pressures from rising inflation are becoming more apparent, HMRC are providing a self-serve Time To Pay facility.

If you have concerns about paying your bill, do contact HMRC for guidance.

The beauty of doing your tax online is that you do not have to complete it all in one go.

If you find you are missing some information you can save your progress and then go back to it once you have found

Conversely, if you have made a mistake, you can rectify it before you submit your

We would always advise that you check, check and then check again before you submit your return.

You can correct any mistake up until the following year's filing deadline so if you

discover down the line that you have made a mistake on your 2020/21 submission, you have until January 31 2023 to contact HMRC and advise them.

When it comes to doing your online tax return, the importance of good record keeping pays dividends.

You don't want to be searching high and low for that missing invoice or receipt, turning the house and the office upside

If you use a cloud accounting package like Xero or Quickbooks, the process becomes even easier. If you are new to selfassessment tax returns, do make sure you start the process as early as possible.

Ongo joins forces with Juj to launch 'Train to Taxi' scheme

ONGO are working with local taxi company Juj, based in Scunthorpe, to offer jobseekers a unique opportunity into employment.

The 'Train to Taxi' scheme launched in November 2021, giving 10 people the chance to benefit from all of the necessary training to be awarded their badge and become a self-

Requirements including an enhanced DBS, medical, liability insurance and safeguarding are included. All that is required of participants is to be over the age of 25, have a clean driving licence and a passion for the

Training will last a maximum of eight weeks and once in the role, cars will be provided. A commission of 45% can then be earned, with hours decided by them.

Regina Dalmeida, Sparc Manager at Ongo said: "We noticed a huge shortage of taxi drivers in the area, so have created the

scheme to offer a flexible route into sustainable employment.

"To receive all of your training, relevant paperwork and support to become selfemployed is really unique and we're very proud to be offering it. The job can work around other commitments and is a fantastic and life changing opportunity.

"To go through this yourself would cost around £350, so we expect interest to be extremely high. If you're interested we would urge you to get in touch as soon as possible to secure your place."

Along with Juj, other taxi companies are also in talks with Ongo's Sparc project, in the hope of offering even more roles going forward.

The Sparc project aims to help people sustain financial independence and offers opportunities for those who want to set up a business or become self-employed.



More than 50 people have benefited from the project over last 12 months, with that number set to rise.

Councils Partnership calls for greater investments

IN response to two major strategic transport consultations, the South and East Lincolnshire Councils Partnership (Boston Borough Council, East Lindsey District Council, and South Holland District Council) has called for greater investment in public transport, roads, and green transport infrastructure.

In its recent responses to both Highways England's 'Vision for Route Strategies' consultation and Lincolnshire County Council's Local Transport Plan consultation, the Partnership highlighted the need for a more ambitious transport plan for the area, in order to attract the investment needed to improve local transport infrastructure for the benefit of residents and businesses across the sub-region.

THE PARTNERSHIP HAS **SPECIFICALLY CALLED FOR:**

■ Major investment in the A16 and A17 to recognise the route's national significance and to support residents, visitors and businesses. especially those within the Agrifood sector, an industry in which the area is a national leader.

- ■Investment in the road network that links the area's rural communities together, and measures to address congestion, noise, and air pollution to preserve the area's natural environment.
- Further investment in public transport to ensure residents have better access to vital public services and greater employment
- ■Upgrades to rail connectivity that can support residents, visitors and businesses and help address a historic lack of funding in rail infrastructure in the area.
- Investment in 'green' transport infrastructure, including electric buses and electric vehicle charging, to ensure the area is future proofed as transport habits change in response to climate change.

Following submission of the responses, the Partnership has affirmed its commitment to now working with partners to ensure that the needs and aspirations for transport across South and East Lincolnshire can be delivered.



New-look Lincoln Drill THE DRILL Hall returns

Renovated, restored and reinvigorated, the theatre and entertainment venue, formerly known as Lincoln Drill Hall is set to reopen its doors next month as The Drill.

The ambitious and extensive refurbishment is nearing completion, under the stewardship of Lincoln College, which stepped in to save the venue after it closed in 2020.

The relaunched venue's first public performances begun from 11th December with the much anticipated pantomime, Aladdin. This will be followed by a short closure for some final finishing touches, before a grand opening that is planned for early February.

With a past as eclectic and illustrious as the acts that have graced its stage, the building has been dramatically reimagined to bring new energy into this iconic venue at the heart of the community.
